## **Stepparents and Stepfamily Dynamics: What Family Law Professionals Need to Understand about What Works (and What Doesn't) in “Blended Families”**

After separation or divorce, most parents eventually recouple, yet stepparents and stepfamily dynamics are still missing from the majority of parenting plans, parenting plan evaluations, court orders, and therapeutic interventions. This keynote shines a light on what family law professionals need to know about the unique structure and challenges of stepfamilies, including their frequent role in Resist/Refuse dynamics.

Drawing on current research, the session explores what supports stepfamilies in functioning well, and what tends to go wrong when old maps are used to navigate new realities. Participants will leave with a better understanding of how to bring stepfamily-specific knowledge into their work to support children's wellbeing and make more informed decisions in conflicted parenting disputes.

## Managing Challenges in Mediation

Join Brad and Judith as they compare their mediation practices, the challenges they commonly encounter, and the increasing complexities of recent years.

They'll highlight important protocols and the tools they use for navigating these difficulties and outline how other professionals can better prepare clients for mediation and help set the stage for productive discussions and successful resolutions.

## **Diverse Voices Panel: How do you develop a diversity lens.**

This panel brings together lived experience and professional insight to explore how culture, religion, ability, and other aspects of identity shape family dynamics and influence decision-making in legal and mental health contexts. With voices from lawyers and mental health professionals, we'll examine what it means to develop a "diversity lens" in your work, especially when navigating unfamiliar territory.

Panelists will share strategies for recognizing the limits of your own knowledge and offer practical ways to respond when you're outside your depth. How do you ask the right questions? How do you avoid doing harm, even with good intentions? And how can you be most helpful in moments where identity, culture, or accessibility matter deeply, but understanding is incomplete?

This session encourages reflection, humility, and a commitment to learning, equipping attendees with tools to approach their work with families in more inclusive and culturally responsive ways.

## Domestic Violence Screening in Family Law: Why It Matters and How to Do It Well

Screening for domestic violence is the first and most vital step in creating safer outcomes for children and families.

This session explores the purpose and power of structured screening in family law, with a focus on asking the right questions in the right way. The why, the how and the what next of screening will be discussed, such as:

- who should you screen first and does that order matter?
- what tools are available and appropriate, what do you do with the information once you have it? and
- why is screening necessary even when there are no obvious red flags?

This session will be appropriate for both beginner and intermediate professionals seeking to build or strengthen their skills in this essential area.

Participants will walk away with recommended tools and resources.


## A Cross-Examination of a Parenting Expert: A Live Demonstration!




